

**SHEBOYGAN COUNTY    ORDINANCE NO. 11 (2017/18)**

Re:    **Amending Section 75.07(2)(a) and 75.17(2)(a) of the Sheboygan County Erosion Control Ordinance (Removing of Town of Wilson Exception)**

**WHEREAS**, currently the Sheboygan County Erosion Control Ordinance applies to all towns except the towns of Sheboygan and Wilson which have chosen to have their own Erosion Control Ordinance, and

**WHEREAS**, the Town of Wilson intends to repeal its Erosion Control Ordinance which means the authority will default to the County, and

**WHEREAS**, in the event the Town of Wilson repeals its Ordinance, Sheboygan County's Ordinance will need to be amended to eliminate the exclusion of the Town of Wilson from the provisions of the County Ordinance, and

**WHEREAS**, a public hearing was held on January 23, 2018, as required by Wis. Stat. § 59.69, for which this proposed revision to the current Ordinance as set forth below was presented for public review and comment

**NOW, THEREFORE**, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1.    **Amending Code.** Sections 75.07(2)(a) and 75.17(2)(a) of the Sheboygan County Code of Ordinances are hereby amended as follows (additions indicated by redlining, deletions by strikeouts; only those portions affected appear):

75.07(2)        JURISDICTION. This **Subchapter A** applies to land-disturbing construction activity meeting the applicability criteria in Subsection (1), above, located within the boundaries and jurisdiction of the:

(a)            Unincorporated portions of Sheboygan County with the exception of the ~~Towns of Wilson and~~ Town of Sheboygan.

75.17(2)        JURISDICTION. This **Subchapter B** applies to post-construction sites meeting the applicability criteria in Subsection (1), above, within the boundaries and jurisdiction of the:

Section 2. **Effective Date.** The herein Ordinance shall take effect upon enactment and confirmation that the Town has repealed its Ordinance.
