# DOES YOUR CONSTRUCTION PROJECT NEED AN EROSION CONTROL AND STORMWATER MANAGEMENT PERMIT?

### An EROSION CONTROL permit is needed for construction if the answer is 'yes' to BOTH of the following questions.

- 1. Is the project taking place in one of the townships in Sheboygan County, other than the Town of Sheboygan? Please contact the Town of Sheboygan for more information if applicable.
- 2. Will the area of disturbance exceed one acre?

Disturbance refers to activities such as excavation, clearing and grubbing, and grading, among others. If unsure whether disturbance exceeds one acre, send the Department a map of the proposed activity locations to plancon@sheboygancounty.com.

## A STORMWATER MANAGEMENT permit is also needed for construction if the answer is 'yes' to AT LEAST ONE of the following questions.

- 1. Will there be over one acre of impervious surface after the project is complete?
  - Impervious surface includes buildings, parking lots, and sidewalks, among others. If unsure whether impervious surface will exceed one acre, send the Department a map of the proposed development to plancon@sheboygancounty.com.
- 2. Will at least 10% of the site consist of impervious area?
  - If unsure whether impervious surface will exceed 10% of the site, send the Department a map of the proposed development to plancon@sheboygancounty.com.

### Permit application process

- 1. Complete the Sheboygan County Erosion Control and Stormwater Management Permit application.
- 2. Create an Erosion Control Plan and (if applicable) Stormwater Management Plan. Compile all supporting documents as required in the Sheboygan County guide.
- 3. Submit the application, fee, and plan documents to the Planning & Conservation Department.\*
- 4. The Department will review the plan and approve, conditionally approve, or deny the application within 30 days.
- 5. If requested, provide additional information to the Department based on the plan review.
- 6. Once the Department has reviewed the updated information (if applicable), it will issue the permit.
- 7. The permit is valid for 180 days or the length of the building permit.

#### Notes

- If your project is part of a larger common plan of development, such as a multi-phase commercial development or subdivision, a permit may still be needed if total acreage exceeds one acre, even if individual projects are under one acre in size.
- As a general rule, if your project requires a Notice of Intent from the WI Department of Natural Resources, it likely needs an Erosion Control and Stormwater Management permit from Sheboygan County.
- Applicants are encouraged to consult with the Department prior to application submission.
