Upcoming Events 2021:

Drain Campaign (June 4th-6th 2021): A statewide annual campaign led by the WDNR and AIS partners to help promote the message of draining boats and bait buckets before leaving boat landings/launches. AIS partners, led by AIS Coordinator Patrick Siwula (Sheboygan County Planning and Conservation) will be out at landings/launches and shorelines to educate the public and provide anglers with ice packs as an alternative to transporting their fish in lake water.

Landing Blitz (July 1st – 5th 2021): AIS staff and volunteers throughout the county will be out at boat landings the 4th of July weekend helping boaters understand the AIS prevention steps: Inspect, Remove, Drain, and Never Move. Towels printed with the prevention message as well as many other giveaways are handed out as a reminder to take action in preventing the spread of aquatic invasive species.

AIS Snapshot Day (August 21st 2021): Join other aquatic ambassadors at one or more of our many rendezvous sites around Sheboygan County for the annual AIS Snapshot Day. Hosted in partnership with UW-Extensions Citizen Lake Monitoring Network, this event will get you out on local lakes and streams to search for Invasive Species.

Clean Boats Clean Waters (CBCW) volunteers perform boat and trailer inspections, distribute informational brochures, and educate boaters on how to prevent the spread of invasive species. 1 FREE 2-hour training is all it takes to become a CBCW Boat Inspector/Volunteer!
