## SHEBOYGAN COUNTY ORDINANCE NO. <u>02</u> (2021/22)

Re: Final Supervisory District Plan

WHEREAS, pursuant to Wis. Stat. § 59.10(b), the Sheboygan County Board of Supervisors adopted Resolution No. 21 (2021/22) creating a Tentative County Supervisory District Plan after the 2020 federal census, and

**WHEREAS**, the Tentative County Supervisory District Plan was submitted to each municipal governing body in the County for the purpose of adjusting each municipal governing body's wards, pursuant to Wis. Stat. § 5.15(1), and

WHEREAS, each municipal body has made its ward adjustments, and

**WHEREAS**, within sixty (60) days of the ward adjustments, the Sheboygan County Board is required to hold a public hearing and adopt a final supervisory district plan, numbering each district, pursuant to Wis. Stat. § 59.10(3)(b)2;

**NOW, THEREFORE**, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1. <u>Establishing Size of County Board and Setting Boundary District Lines</u>. The provisions of Section 1.02 of Chapter 1 of the Sheboygan County Code of Ordinances are hereby rescinded and re-created to read as set forth on the attached pages which are made a part hereof by reference. Said provisions shall constitute the Final Supervisory District Plan, pursuant to Wis. Stat. § 59.10(3)(b)(2.

Section 2. <u>Publication</u>. The County Clerk is hereby directed to prepare County maps setting forth the District Boundaries upon enactment of the herein Ordinance and to submit two (2) copies to every municipal Clerk in Sheboygan County. Said map shall also set forth the ward boundaries as required within each Supervisory District which are hereby approved for reference. The Chairperson of the County Board shall file a certified copy of this Ordinance with the Secretary of State pursuant to Wis. Stat. § 59.10(3)(b)4.

Section 3. <u>Effective Date</u>. The herein Ordinance shall take effect upon enactment for purposes of the spring elections; but with regard to the incumbent

supervisors, their district boundaries shall remain as at present until the end of their terms, that is, the third Tuesday in April, 2022, to wit: April 19, 2022.
