WHEREAS, upon resigning as County Board Supervisor, Mr. LeMahieu was elected to the 59th District in the Wisconsin State Assembly for 12 years, and

WHEREAS, in addition to serving his community as noted above, he also served in the U.S. Army, and

WHEREAS, Mr. LeMahieu will be remembered for his dedication to the continued improvement of Sheboygan County and his efforts to serve the public interest;
