SHEBOYGAN COUNTY RESOLUTION NO. <u>03</u> (2011/12)

Re: Authorizing an Application for Railroad Improvement Funding and Changing Budget after Levy

- WHEREAS, a revitalized freight rail link between Plymouth and Kohler would be an attractive component for maintaining and improving the manufacturing climate for Sheboygan County, and
- **WHEREAS**, municipalities directly in the pathway of such a rail link are being asked to contribute to the financing of a revitalization project, and
- **WHEREAS**, there is an opportunity being spearheaded by the Sheboygan County Economic Development Corporation to obtain a \$1 Million grant from the Wisconsin Department of Transportation to support Sheboygan County's contribution to the project, and
- **WHEREAS**, the grant terms would require Sheboygan County to contribute \$1,000,000.00 to the project which would be reimbursed to the County from the grant upon expenditure; provided, however, that Sheboygan County shall also contribute \$100,000.00 to the project toward the local match requirements which would not be refunded, and
- **WHEREAS**, no money would be committed to the project unless the grant is awarded to Sheboygan County, and
- **WHEREAS**, the 2011 Sheboygan County Board Budget as adopted on November 2, 2010, does not provide for financing of this project, and
- **WHEREAS**, Wis. Stat. § 65.90(d)(a) provides that the County Board, if authorized by two-thirds (2/3) vote of the Board, may change its budget.
- **NOW, THEREFORE, BE IT RESOLVED** that the 2011 Sheboygan County budget be amended to provide financing in the sum of \$1,100,000 for the Plymouth to Kohler Railroad Project, contingent upon Sheboygan County being awarded the grant and the sum of \$1,000,000 being funded through the grant and \$100,000 being funded by undesignated general fund balance*, with the understanding that the county will not expend the \$100,000 until \$1,900,000 of additional public and private funding is secured.
- **BE IT FURTHER RESOLVED** that the Finance Director is authorized to record the budget amendments and transactions in the appropriate accounts in accordance with Generally Accepted Accounting Principles.
- **BE IT FURTHER RESOLVED** that the appropriate Sheboygan County officials be authorized and directed to apply for and sign the grant application and administer the grant in accordance with its terms and the terms of this Resolution.
