SHEBOYGAN COUNTY RESOLUTION NO. <u>03</u> (2010/11)

Re: Authorizing Sheboygan County Planning Department to Apply for Lake Management Protection Grant for Code Revision Support

WHEREAS, pursuant to Wis. Stat. §§ 59.69, 59.692, and 281.31, Sheboygan County has enacted and administers Chapter 72, The Shoreland Ordinance, Sheboygan County, Wisconsin, and

WHEREAS, the State of Wisconsin has revised Wis. Admin. Code Ch. NR 115, the statewide minimum standards for shoreland zoning which will require Sheboygan County to revise its Shoreland Ordinance no later than February 1, 2012, and

WHEREAS, revision of Sheboygan County's Shoreland Ordinance consistent with the new requirements of Wis. Admin. Code Ch. NR 115 will enhance the public health, safety, and convenience of Sheboygan County and improve its tax base; will prevent and control water pollution; will protect spawning grounds, fish, and aquatic life; will control building sites, placement of structures, and land uses; will discourage development of erosion hazard areas, particularly along the coast of Lake Michigan; and will preserve shore cover and natural beauty, and

WHEREAS, the State of Wisconsin, Department of Natural Resources administers a lakes protection grant program which could provide financial assistance to Sheboygan County as it moves forward to review its Shoreland Ordinance, and

WHEREAS, it would be desirable for the Planning Department to submit an application to the Wisconsin Department of Natural Resources under the "Lake Management Protection Grant Program" to obtain financial support for the project in the manner set forth in the draft application, a copy of which is on file in the Office of the Sheboygan County Clerk;

NOW, THEREFORE, BE IT RESOLVED that James Hulbert, Planning Department Director, be authorized to act on behalf of Sheboygan County to submit an application to the State of Wisconsin Department of Natural Resources "Lake Management Grant Program" for any financial aid that may be available; sign documents as required; and take necessary action to undertake, direct, and complete the approved project.
