## SHEBOYGAN COUNTY RESOLUTION NO. 35 (2010/11)

Re: Authorizing Human Resources Committee to Enter into Labor Contract with Sheboygan County Social Workers Local 437, AFSCME, AFL-CIO

WHEREAS, tentative agreement has been reached with regard to a new labor contract for employees within the Sheboygan County Social Workers, Local 437, AFSCME, AFL-CIO, for a two- (2-) year term commencing January 1, 2011, and ending December 31, 2012, and

**WHEREAS**, in addition to nominal language changes, the proposed changes to the existing contract can be summarized as follows:

1. **DURATION** Article 31 – Two (2) years: January 1, 2011, through December 31, 2012.

2. **WAGES** Article 8 – Effective January 1, 2011 – 0.0% across-the-board Effective January 1, 2012 – 1.5% across-the-board

3. **WORK WEEK** Article 11 – Revise by deleting the second sentence and by deleting the phrase "Starting 1-1-2008" from the third sentence.

4. **LONGEVITY** Article 12 – Revise by deleting current second paragraph *and* the table and replacing it with the following:

Employees hired after January 1, 1995, and who have continuously worked for the following number of years shall be paid longevity (with rates rounded to the nearest hundredth of a cent) as hereinafter set forth.

Effective January 1, 2011

After 5 years - \$0.1154 per hour After 10 years - \$0.1731 per hour After 15 years - \$0.2308 per hour

Effective January 1, 2012

After 5 years - \$0.2245 per hour After 10 years - \$0.2755 per hour After 15 years - \$0.3368 per hour

5. OVERTIME/ COMP TIME Article 13 – Revise by:

Deleting Section IV.B;

Deleting "Starting on 1-1-2008" from Subsection C; and Renaming current Subsection C as new Subsection B.

**NOW, THEREFORE, BE IT RESOLVED**, that by the adoption of this Resolution, the tentative agreement is hereby approved, and the Human Resources Committee is hereby authorized to execute, on behalf of Sheboygan County, a new labor contract with the Social Workers, Local 437, which includes the terms of the tentative agreement.
