Re: **Modifying Leadership Structure of Health and Human Services Table of Organization (T/O)**

WHEREAS, an upcoming retirement within the Health and Human Services Department, coupled with revisions to the mechanics of Health and Human Services Department provision of services, provide for an opportunity to make modifications to the leadership structure of the Health and Human Services Department, and

WHEREAS, the replacement of the Community Programs/Elder Services Manager position with a new deputy director position with oversight over the Social Services, Community Programs/Elder Services, and Public Health divisions will provide greater opportunity to build efficiencies and interdivisional cooperation;

NOW, THEREFORE, the County Board of Supervisors of the County of Sheboygan does ordain as follows:
