SHEBOYGAN COUNTY ORDINANCE NO. 12 (2010/11)

Re: Amending Sheriff's Department Table of Organization

WHEREAS, the recent organizational study undertaken by Virchow Krause recommends certain modifications to the Sheriff's Department Table of Organization which, in part, the Law Committee believes to be in the best interest of the Department, and

WHEREAS, one of the recommendations is to move from a sworn officer "Evidence Technician" position to a non-sworn "Property Officer" position, and

WHEREAS, this would allow flexibility to hire qualified staff with the skills to process evidence but who might not otherwise have a law enforcement background at a cost-savings to the County, and

WHEREAS, another recommendation is to allow the Sheriff's Department to have flexibility similar to Rocky Knolls to hire full-time equivalents (FTEs) when it makes financial sense to do so;

NOW, THEREFORE, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1. <u>Amending Section 40.02(20)</u>. Section 40.02(20) of the Sheboygan County Code of Ordinances is hereby amended as follows (amendments shown in bold italics):

Section 2. <u>Amending Section 40.03</u>. Section 40.03 of the Sheboygan County Code of Ordinances is amended to read as follows (amendment shown in bold italics):

40.03 EQUIVALENT POSITIONS AUTHORIZED. With regard to the Table of Organization for Rocky Knoll *and the Sheriff's Department*, each authorized full-time position may be construed to authorize the "equivalent" of one full-time position [that is, forty (40) hours per week], and the position may also be filled by two (2) or more individuals within such hourly equivalent authorization. The herein equivalent shall not apply to any other subsections of the other Tables of Organization.

The exact number of authorized positions in each classification permitted under the above subsection shall be determined by the Health Care Centers Committee as to Rocky Knoll or the Law Committee as to the Sheriff's Department, but in no event shall it exceed the total set forth in said subsection.
