SHEBOYGAN COUNTY ORDINANCE NO. 20 (2010/11)

Re: Establishing Speed Zones on County Roads "D" and "EE" (Towns of Holland and Wilson Respectively)

WHEREAS, pursuant to Wis. Stat. § 349.11, in the interest of safety, the Transportation Committee recommends that to maintain reasonable and safe speed zones, the present speed zones on a portion of County Roads "D" in the Town of Holland and "EE" in the Town of Wilson be reduced as hereinafter specified.

NOW, THEREFORE, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1. <u>Changing Speed Zone</u>. The provisions of Sections 20.03(3) and (13) of the County Code of Ordinances are hereby amended to read as follows (redlining indicates additions, strikeouts indicate deletions):

20.03(3) TOWN OF HOLLAND

- (a) County Road "D" Forty-five miles per hour starting 3,584 feet west of Six Mile Road for a distance of 4,768 feet.
- (a)(b) County Road "K" Dacada. Thirty miles per hour for all vehicles from its intersection with County Road "B" westerly for a distance of 0.63 miles.
- (b)(c) County Road "AA" Forty-five miles per hour for all vehicles from a point 0.13 of a mile east of Sauk Trail Road westerly to the Oostburg Village limits.
- (e)(d) County Road "RR" Thirty-five miles per hour from its intersection with County Road "LL" westerly for a distance of 0.22 miles to its intersection with County Road "LLL."
- (d)(e) County Road "LLL" Thirty-five miles per hour from its intersection with County Road "RR" southerly for a distance of 0.22 miles to its intersection with County Road "LL."
- (e)(f) County Road "KK" Thirty-five miles per hour from a point 900 feet East of the intersection of County Road "A" easterly for a distance of 1,100 feet to the Village of Oostburg Village limits.

20.03(13) TOWN OF WILSON

- (a) County Road "EE"
 - 1. Twenty-five miles per hour from the north junction with South 12th Street easterly to the City of Sheboygan city limits at South Eighth Street and then thirty-five miles per hour to its intersection with Lake Shore Drive.
 - 2. Forty miles per hour for all vehicles from Lake Shore Drive south to Evergreen Drive.

- 3. Thirty-five miles per hour for all vehicles from Evergreen Drive westerly to its south intersection with County Road "KK."
- 4. Thirty-five miles per hour from its intersection with County Road "A" easterly for a distance of 2.43 miles to its intersection with County Road "KK."
- 5. Forty-five miles per hour from its intersection with State Highway 28 southerly for a distance of 4,200 feet.

Section 2. <u>Effective Date</u>. The herein Ordinance shall take effect upon adoption by the County Board, approval of the Department of Transportation, publication, and installation of appropriate signage.
