SHEBOYGAN COUNTY ORDINANCE NO. <u>01</u> (2015/16)

Re: Adding Lakeland College to Representative of Airport Advisory Committee

WHEREAS, the Airport Advisory Committee serves as a resource to the Transportation Committee to provide public input on Airport operational matters, and

WHEREAS, Lakeland College has become a major user of the Airport as it expands its aeronautical educational activities, and

WHEREAS, it would be beneficial to have a representative of Lakeland College on the Airport Advisory Committee;

NOW, THEREFORE, the County Board of Supervisors of the County of Sheboygan does ordain as follows:

Section 1. <u>Adding Lakeland College Representative to Airport Advisory Committee</u>. Chapter 65 of the Sheboygan County Code of Ordinances is hereby amended as follows (additions indicated by redlining; deletions by strikeouts; only those sections affected appear):

65.03 MEMBERSHIP. The Committee shall consist of nine (9)ten (10) members which members shall represent the following:

- (a) Two (2) members from the County Board Transportation Committee;
- (b) One (1) member from the Town Board of the Town of Sheboygan Falls;
- (c) One (1) member representing the corporate business community who owns a hangar at the Airport;
- (d) One (1) member representing the private hangar owners:
- (e) One (1) member who is an aircraft owner who rents hangar or tie-down space at the Airport;
- (f) One (1) member who represents the Sheboygan Area Chamber of Commerce; and
- (g) One (1) member representing the Fixed Base Operator-; and
 - h) One (1) member representing Lakeland College.

In addition to the above, a representative from the Airport Department shall serve on the Committee as a resource person but shall not have any voting rights.

65.04 APPOINTMENTS TO THE COMMITTEE. Appointments to the Committee shall be made by the County Board Chairperson as to Transportation Committee members and the County Administrator as to public members from a list of names submitted by the County Board Committee responsible for operation of the airport and subject to confirmation by the County Board. The initial appointments shall be

made so that one-half of the members shall serve a one-year term and one-half shall serve a two-year term. Thereafter, each member shall serve a two-year term unless a vacancy is created, and, in such event, appointments to fill the vacancy shall be for the remainder of the term being filled.

Section 2. <u>Effective Date</u>. The herein Ordinance shall take effect *upon enactment.
